

## Privacy Policy for CertifyReads

This Privacy Policy describes how **CertifyReads** (the "App") collects, uses, and shares your personal information.

### Information We Collect

When you use our App, we collect the following information:

- **Name:** We collect your name as provided by you. This information is used to personalize the PDF certificate generated by the App.
- **Email Address:** We collect your email address. This serves as your unique identifier for login purposes and accessing your account within the App.
- **User Id:** The generated userID is generated and shared with 3rd party provider, supabase to manage the authentication.
- **Credit Card Information:** We collect your credit card data to be sent to a 3rd party provider to buy credits to be able to do an evaluation test. It is not stored, it is collected and processed directly by our third-party payment gateway provider, Stripe, for payment processing purposes.
- **Billing Address (Processed by Third Party):** Please note that billing address information is collected and processed directly by our third-party payment gateway provider, Stripe, for payment processing purposes. This information is entered on Stripe's secure interface and is not directly collected or stored by the App.

### How We Use Your Information

We use the collected information for the following purposes:

- **Name:** Your name is used to personalize and display on the PDF certificates generated by the App.
- **Email Address:** Your email address is used to authenticate your login and provide you with access to your App account.
- **User ID:** It is used as your identification on the platform.
- **Credit Card Information:** Exclusively used and processed by Stripe during the buy process of credits to enable the user to do evaluation tests.
- **Billing Address:** Exclusively used and processed by Stripe during the buy process of credits to enable the user to do evaluation tests.

### Sharing Your Information

We share your personal information with the following third party:

- **Stripe:** We share your name, email address, and billing address with Stripe (our payment gateway provider) solely for the purpose of processing payments and billing related to your use of the App. Please be aware that Stripe's use of your information is governed by its own privacy policy, which we encourage you to review.

### **Third-Party Services**

Except for the integration with Stripe for payment processing, our App does not currently utilize any other third-party services that directly collect personal information from users.

### **Your Rights and Choices**

We will process your request in accordance with applicable laws and our internal procedures.

### **Data Security**
